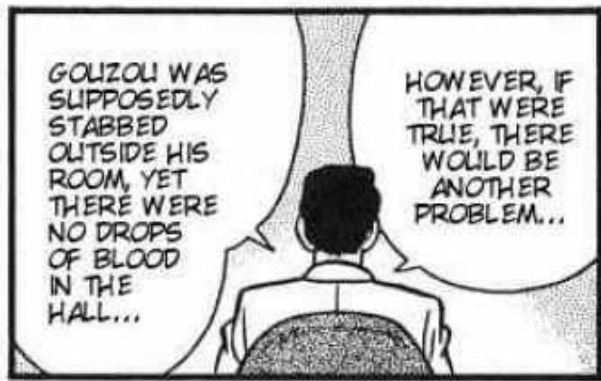

AND IF TATSUO-SAN JUST HAPPENED TO SEE IT...

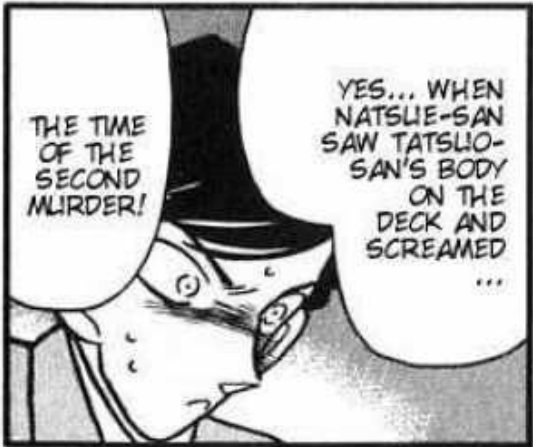
CAN YOU IMAGINE IT LIKE THIS? WHAT WAS THROWN AWAY WAS THE KNIFE FROM THE CASE...

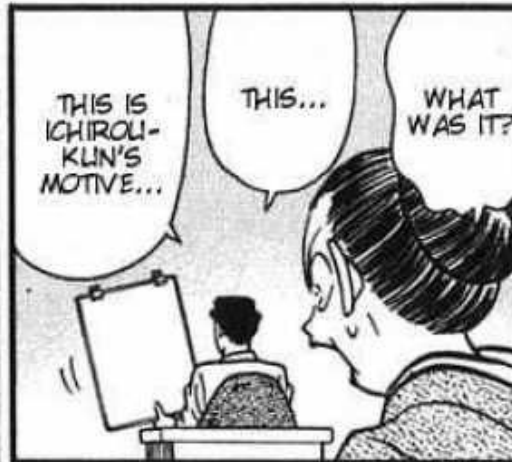

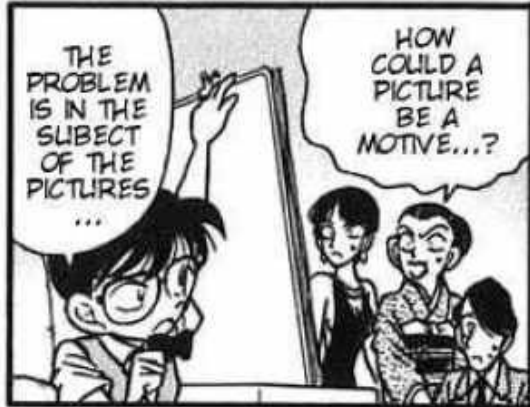
