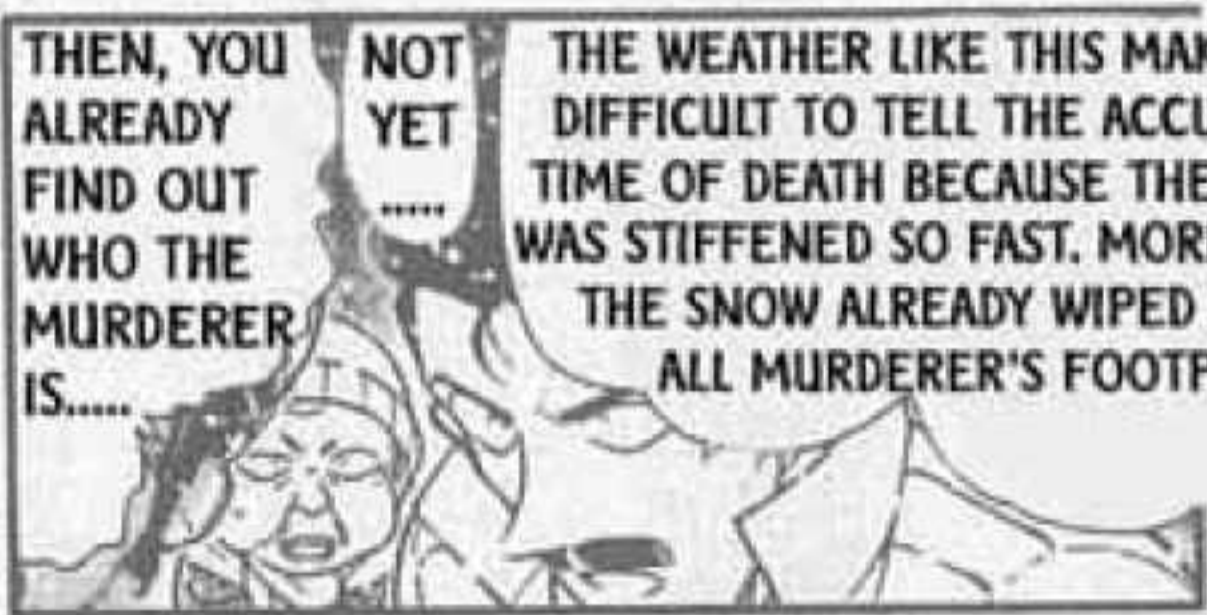

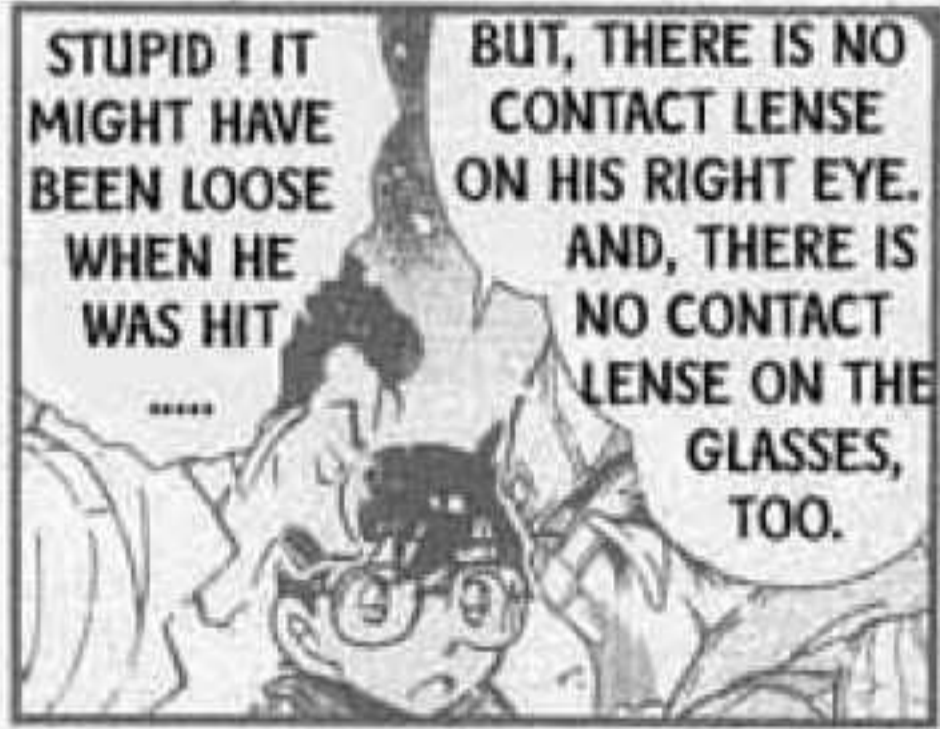

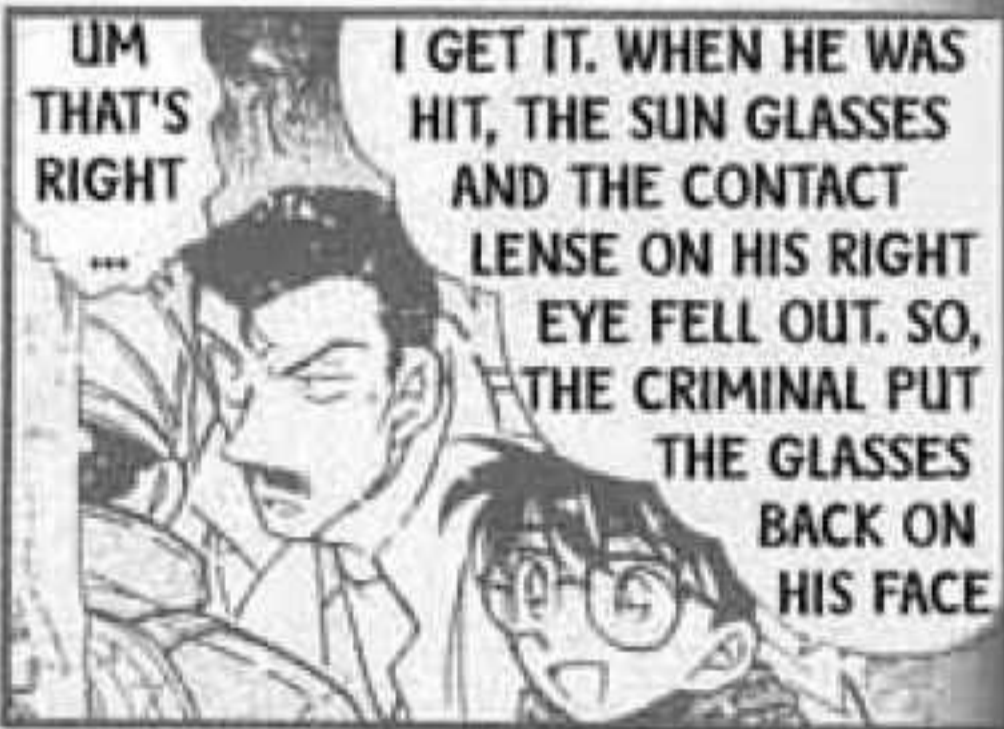


THE CONTACT LENSE IS NOT IN THE CORRECT POSITION !
