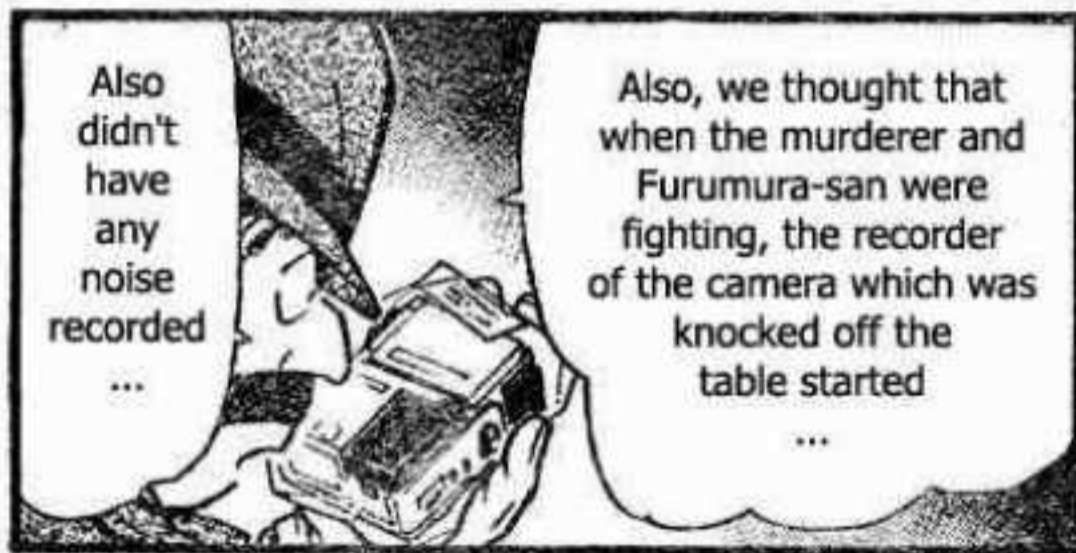
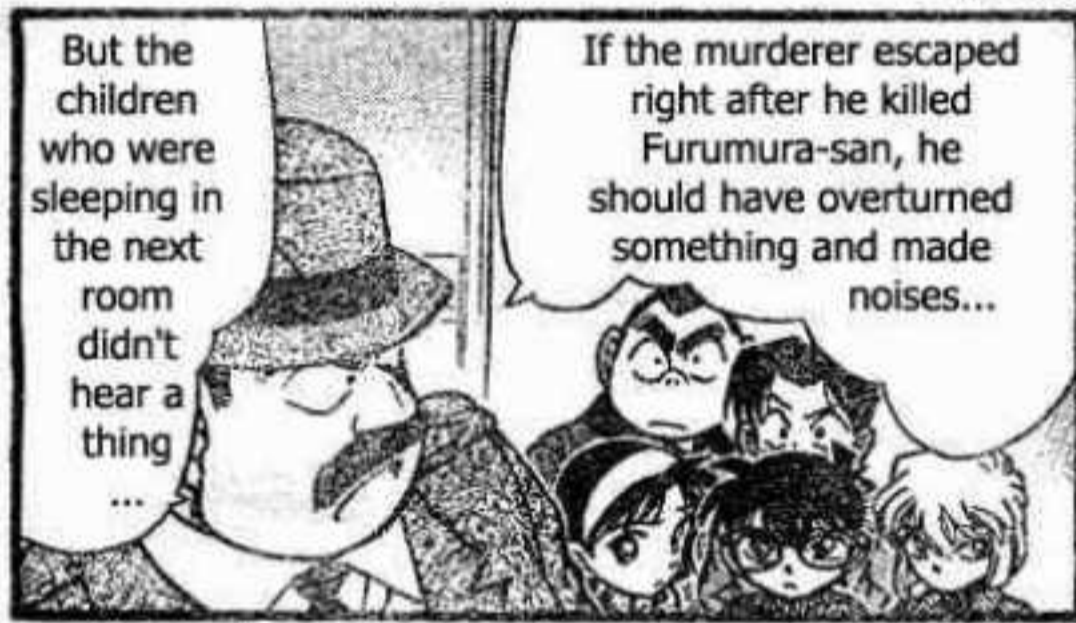
# Mystery of the Black Light

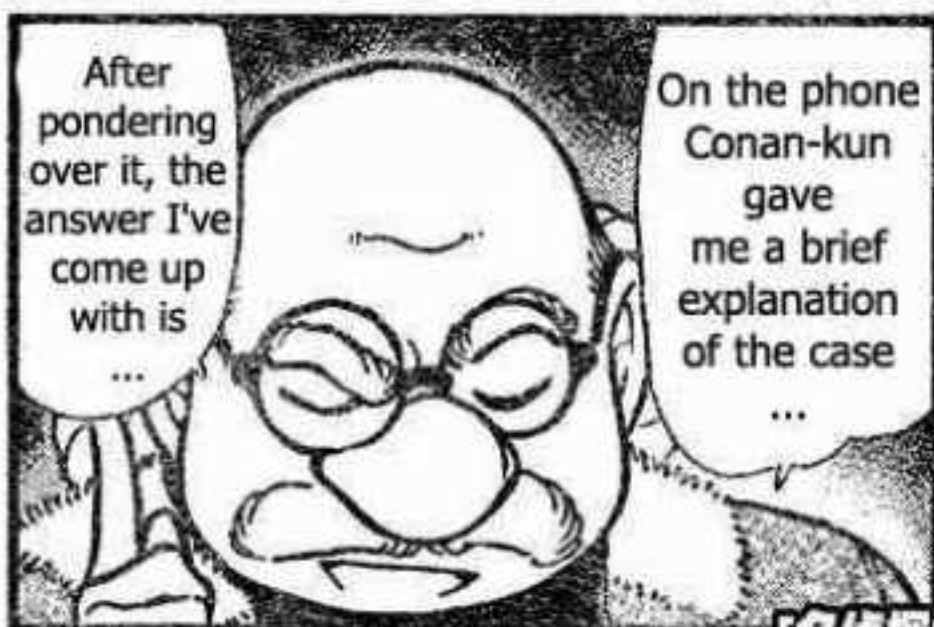
It's Conan-kun who called for me to get you kids ...

Agasa-san... you also think so?

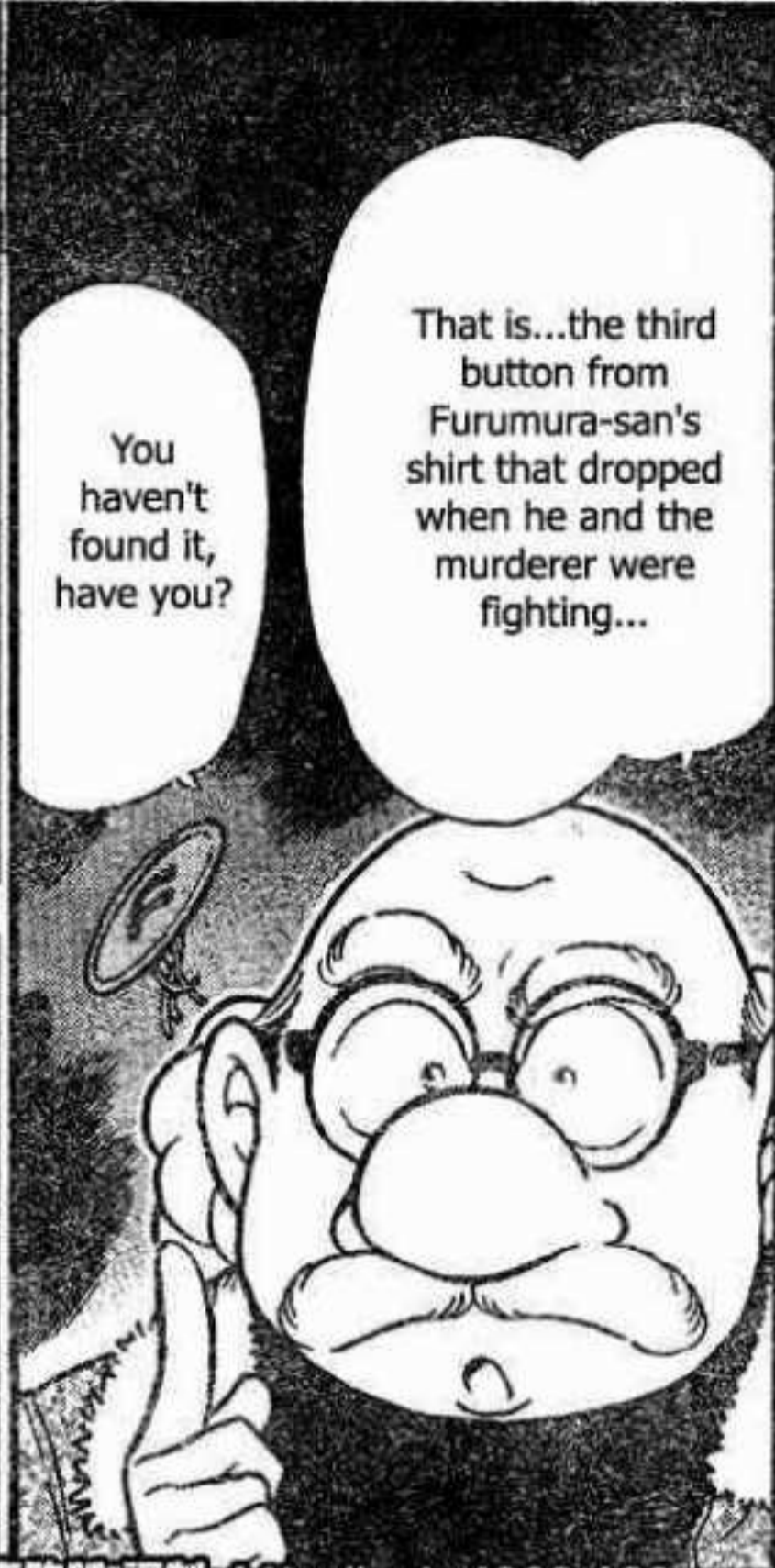
But...if it's a spirit without any legs, then it's another thing!



The button also can't grow wings and fly away itself ...

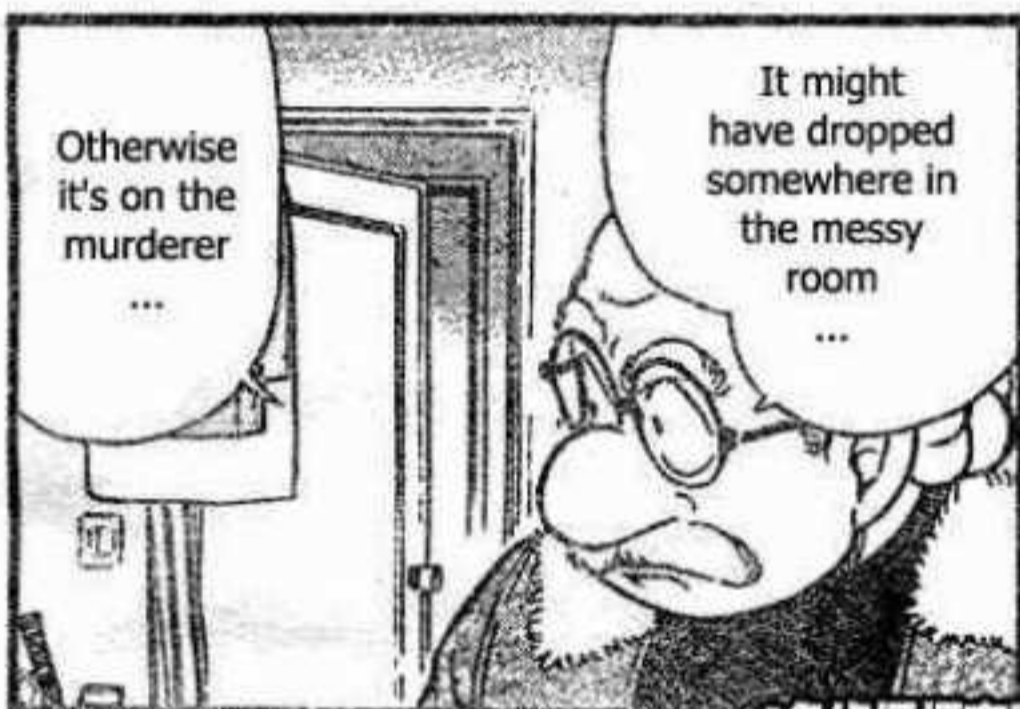
If possible to find that button, everything will be clearer ...

Otherwise it's on the murderer ...

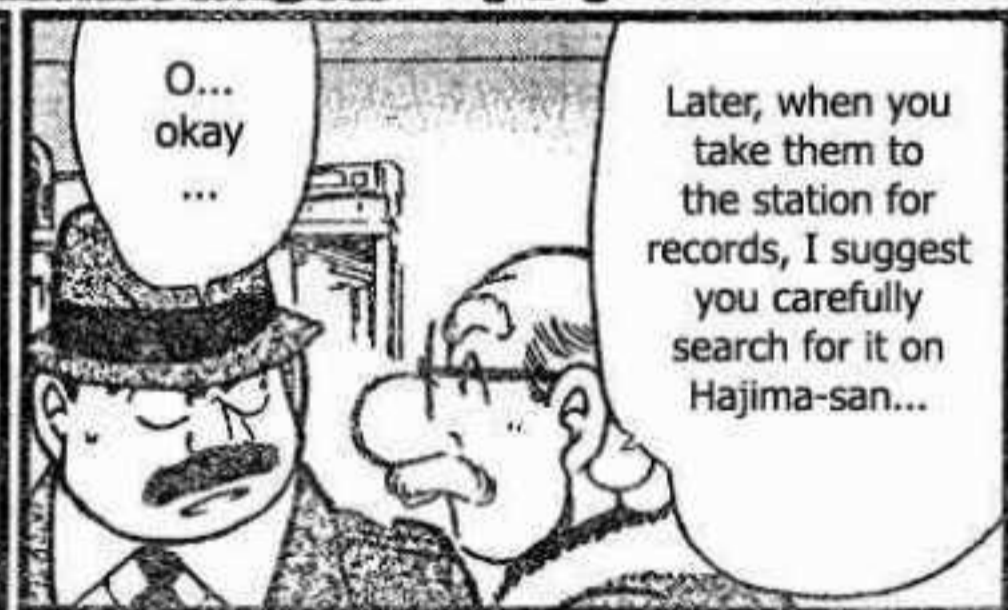
It might have dropped somewhere in the messy room ...

If they weren't recorded, then it's most probably because the murderer turned it on himself, and then put the camera under the table ...

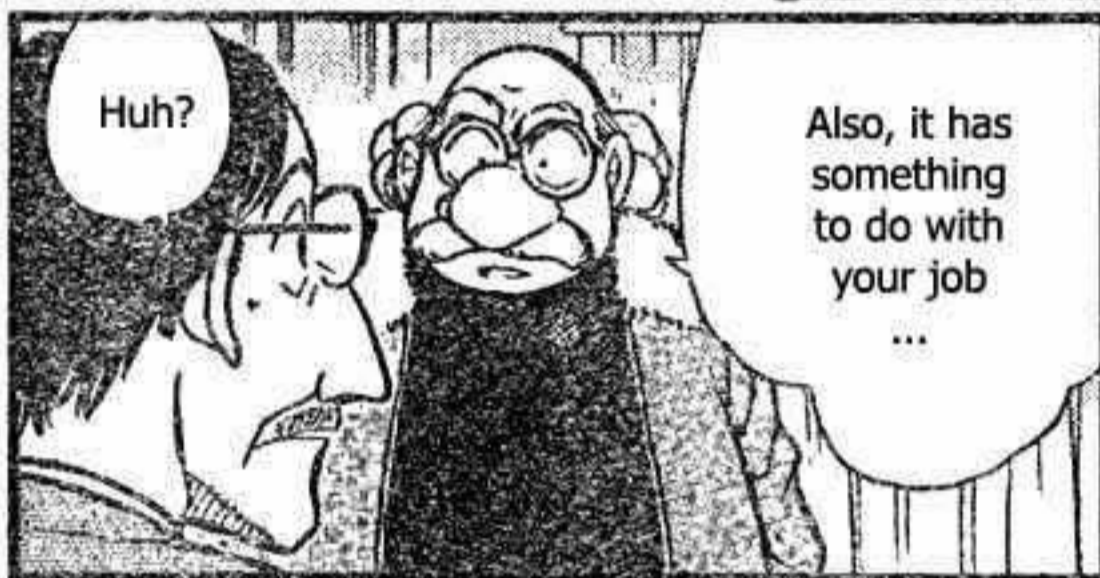


Whether it's the noise of the fight, or of it dropping, it can't suddenly stop when it was turned on accidentally ...

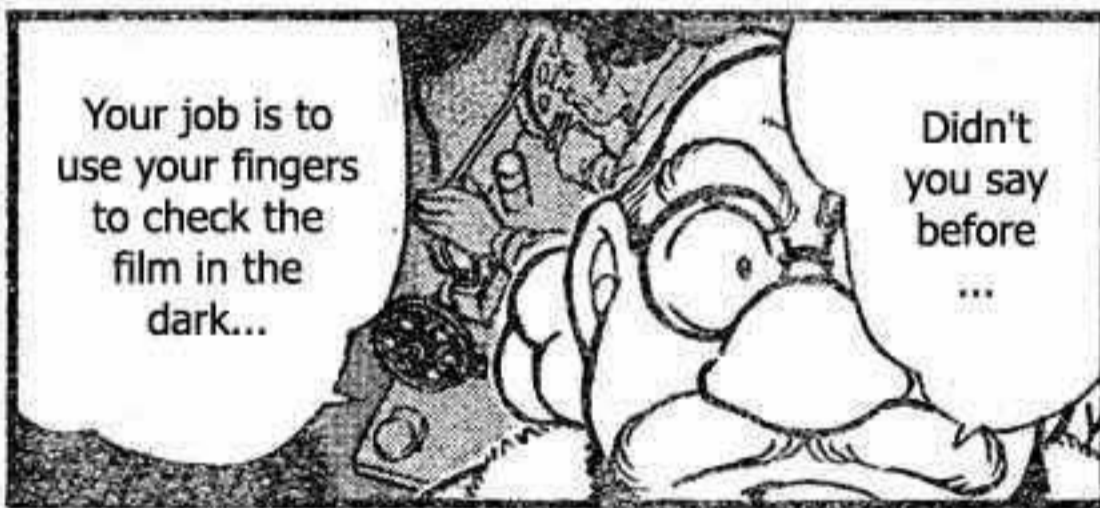


Huh?

Didn't you say before ...

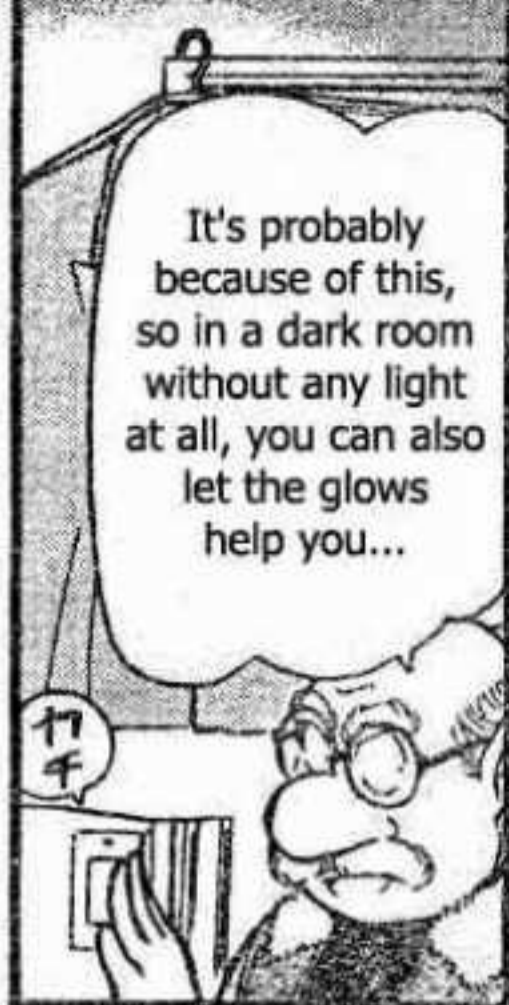


At the corners of the objects that were left messily ...

It's probably a black colored tape over a kind of glowing tape...see! If you peel the black tape a little, then the glowing tape below it will reveal naturally...

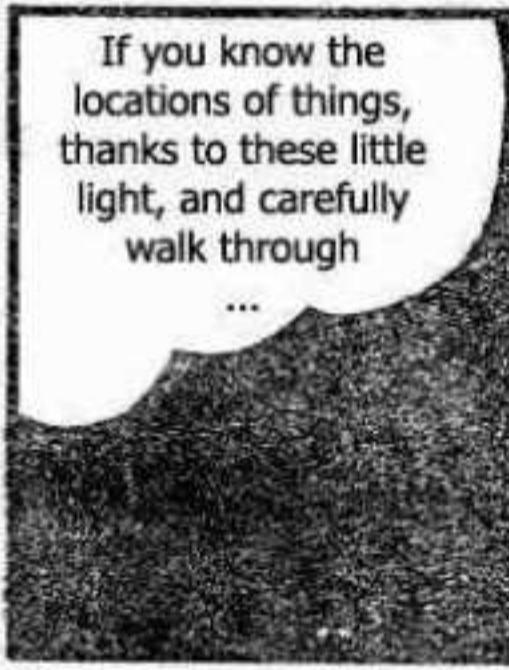


All has a black tape stuck on it!



This way, if you switch off the lights, anyone can see it ...

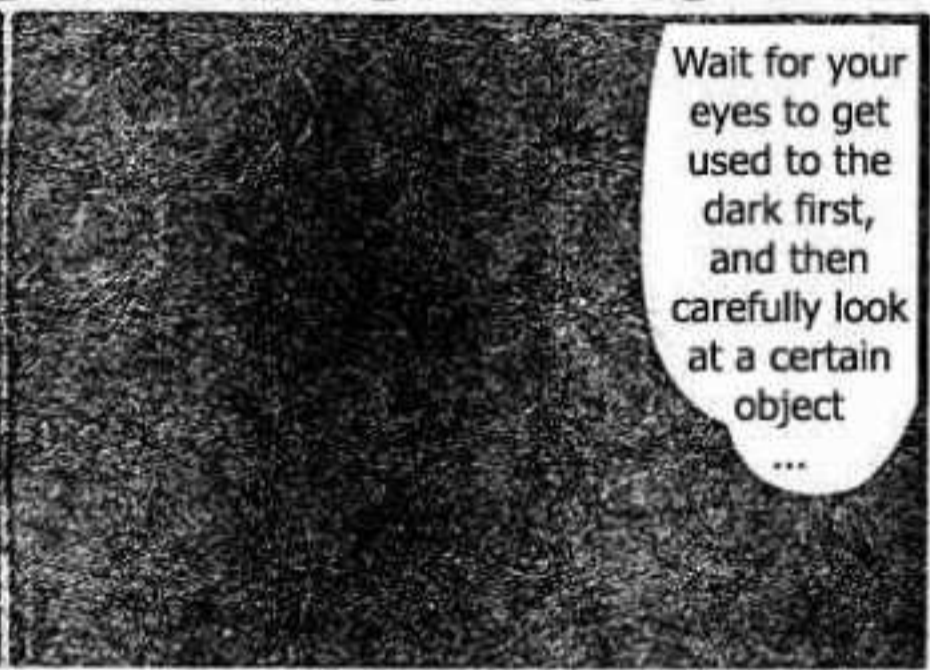

When Gensa-san works in the dark room, he probably stuck this thing in there too ...

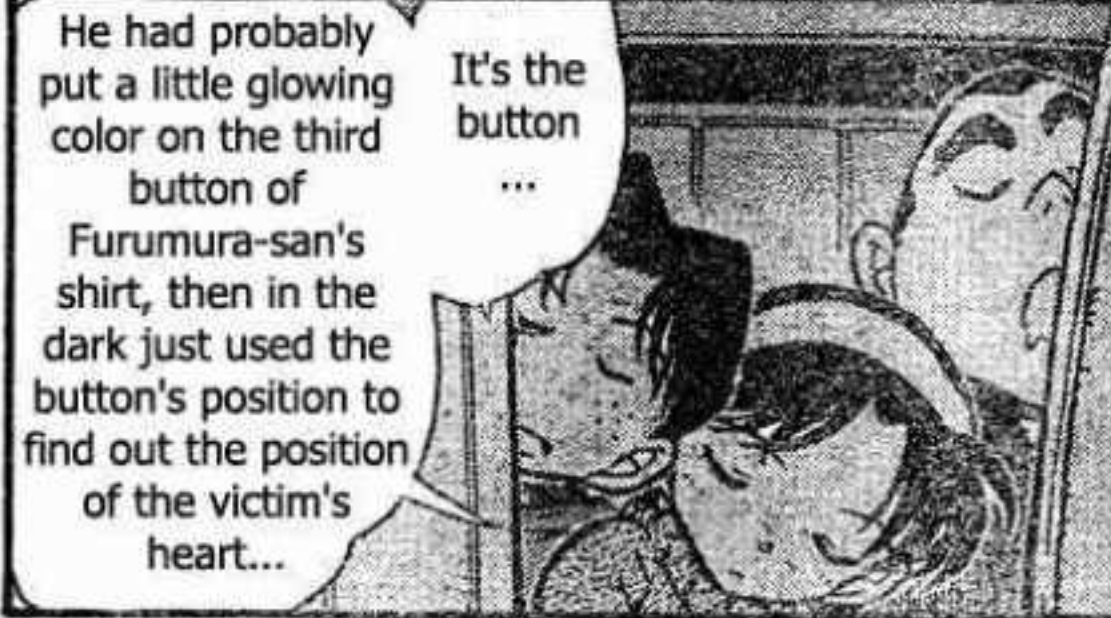

To Furumura-san who doesn't take a bath for a week, the possibility of not changing his shirt is great... also...

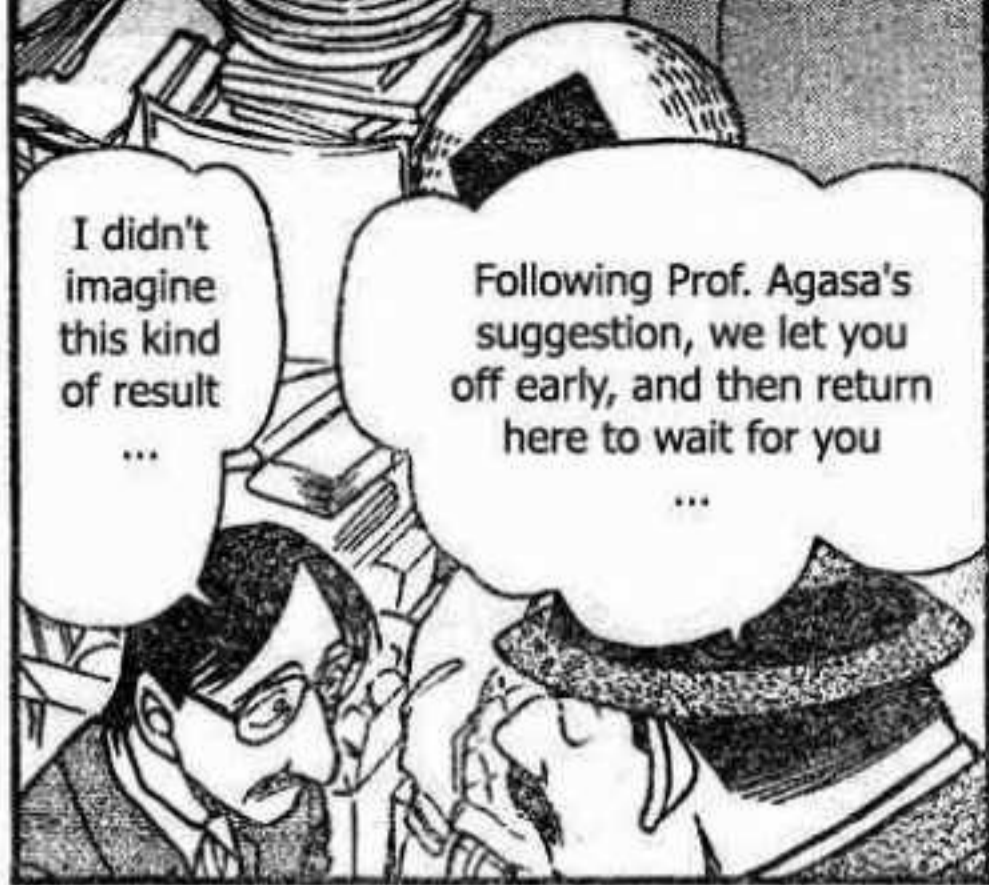
The time of putting the glow, was probably the morning when every member was working, and when Furumura-san because of exhaustion was asleep ...

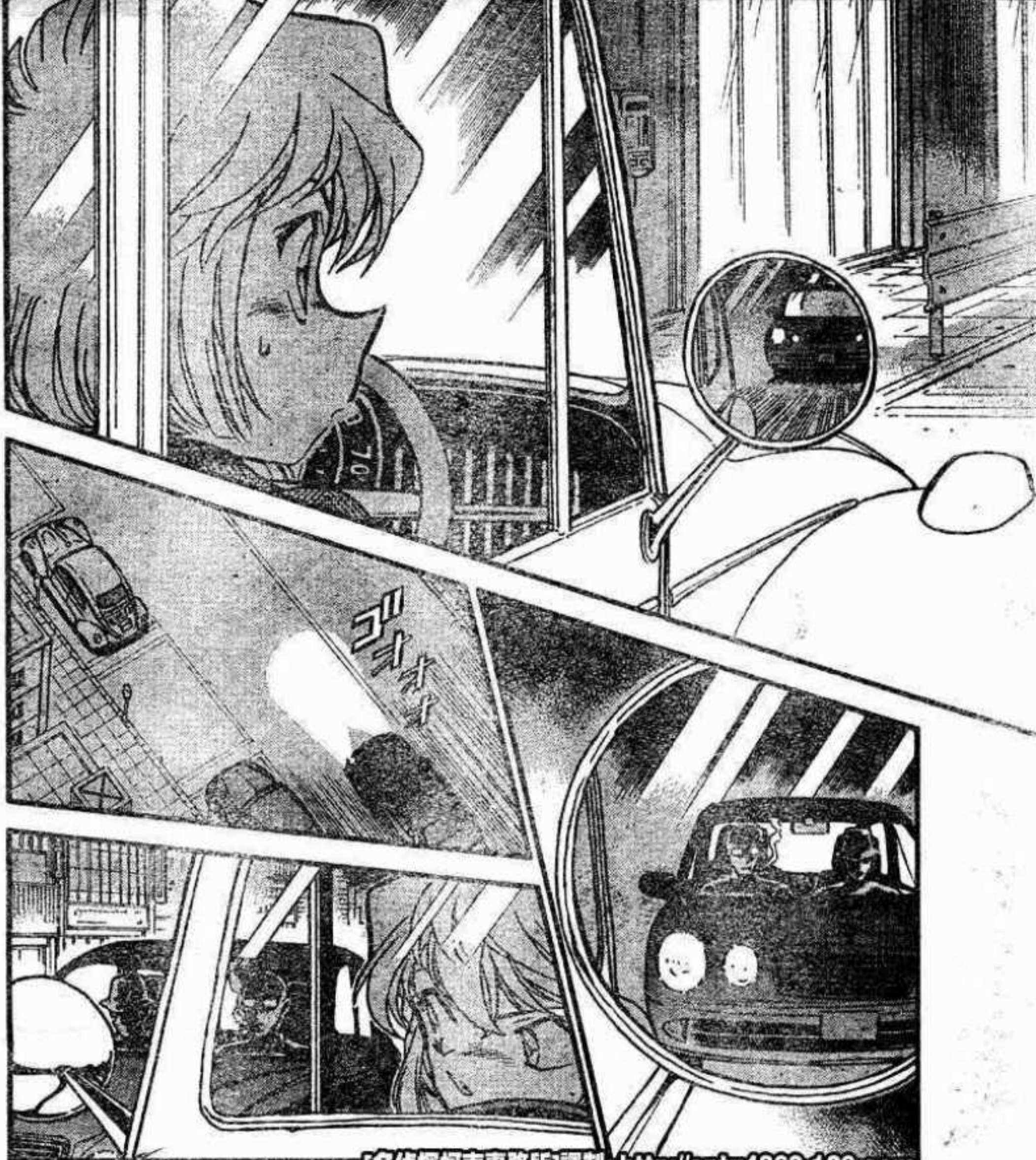

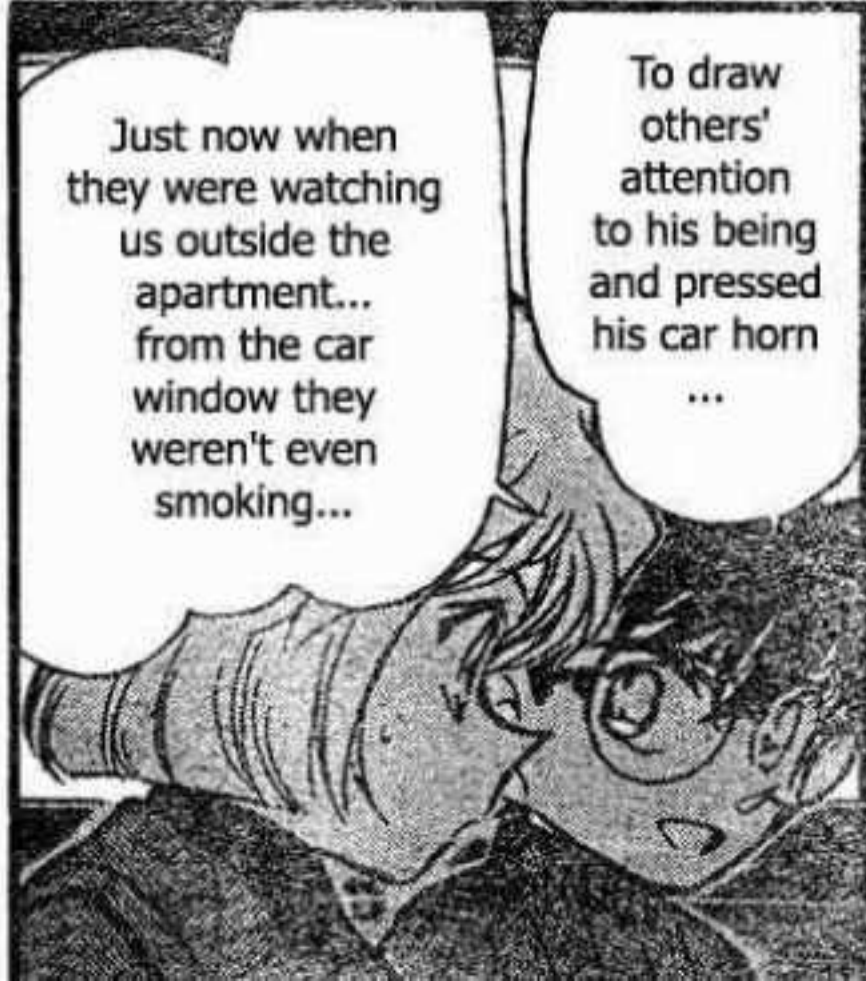

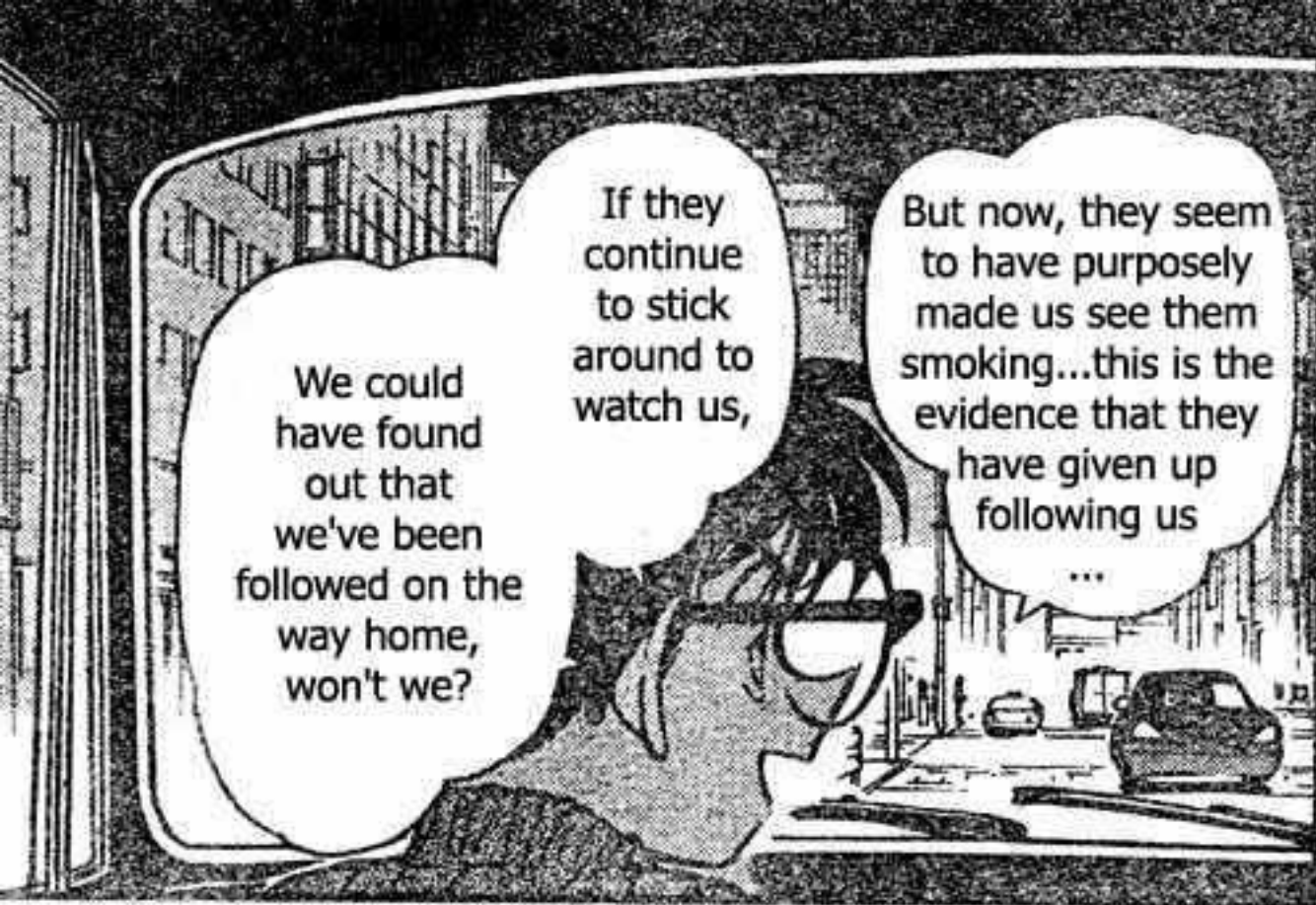

But now, they seem to have purposely made us see them smoking...this is the evidence that they have given up following us

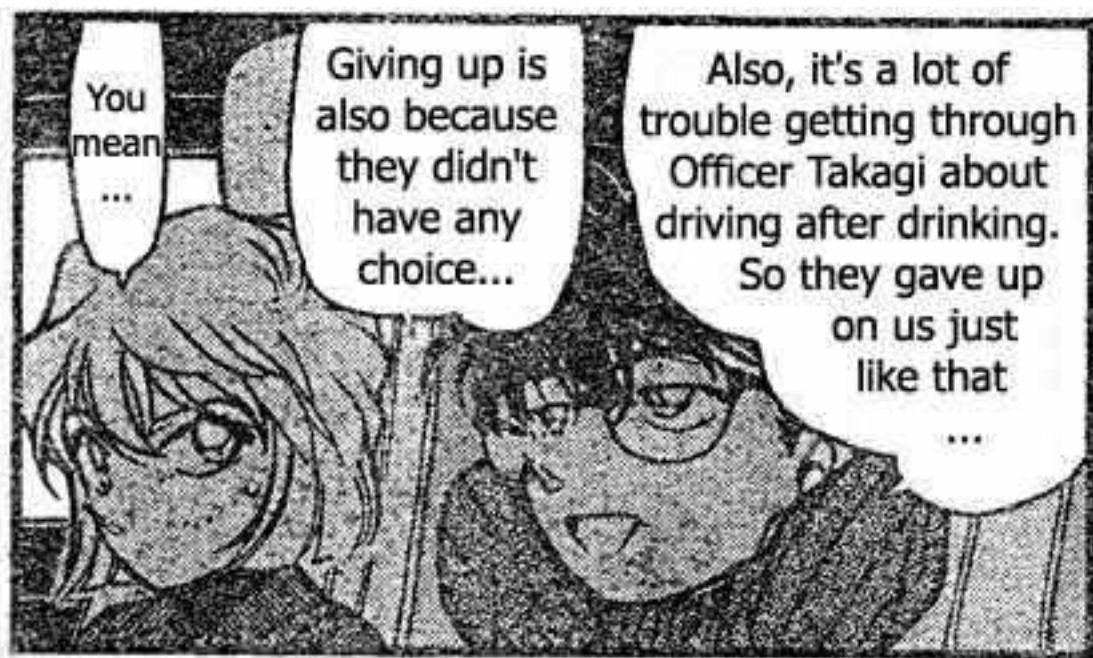

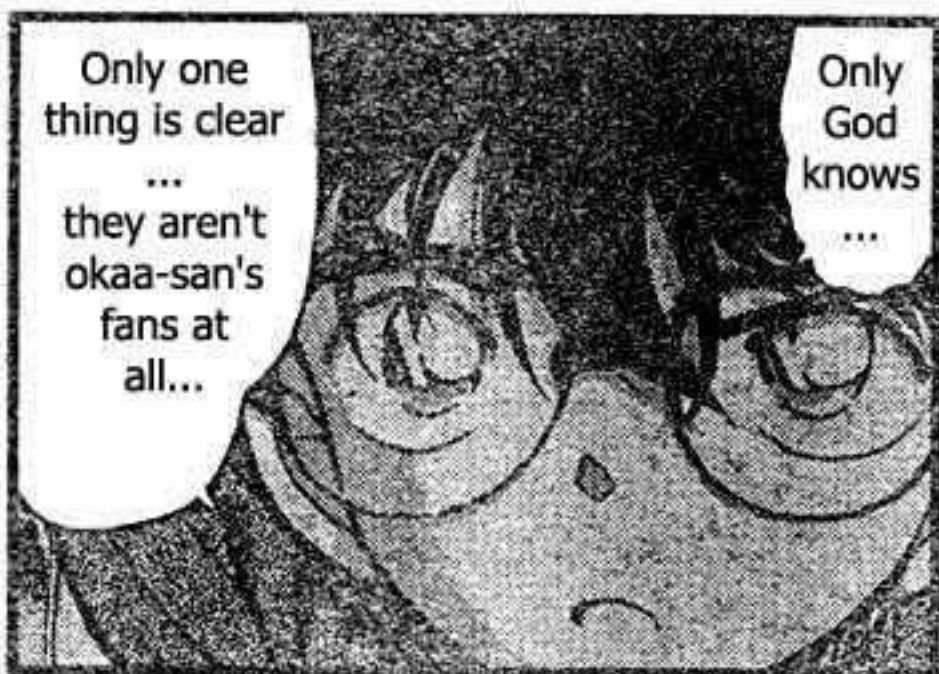


You mean ...

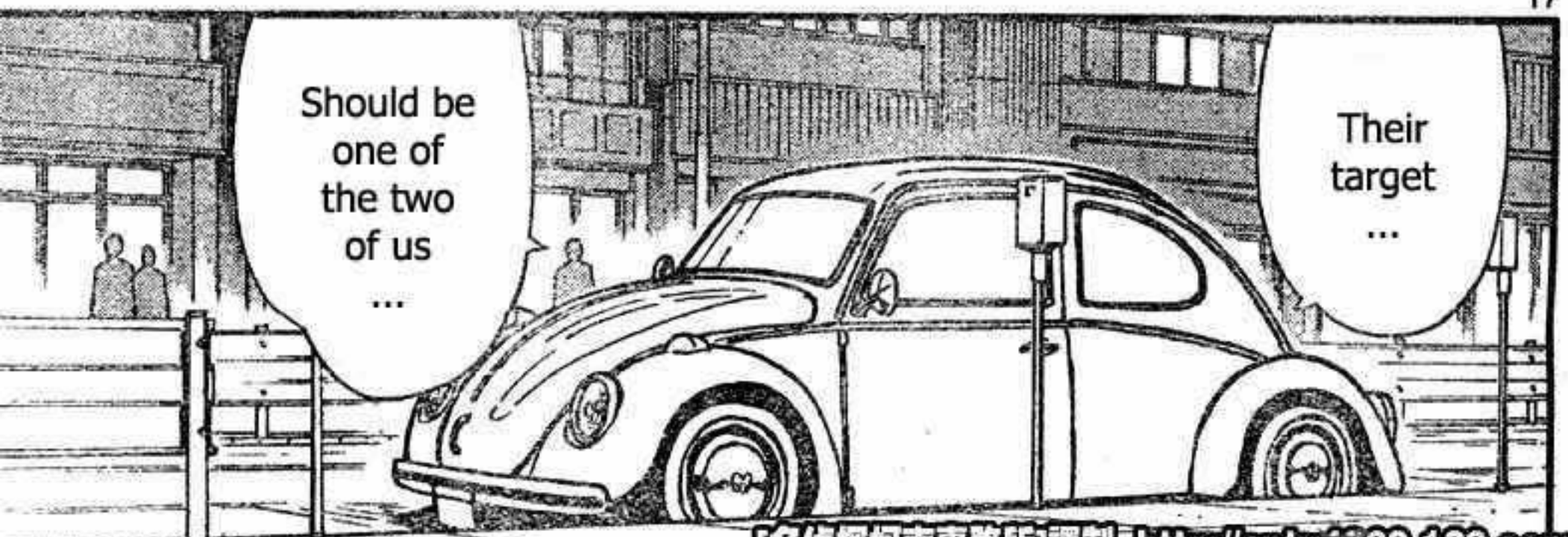
Only one thing is clear ... they aren't okaa-san's fans at all...

Never-mind ...

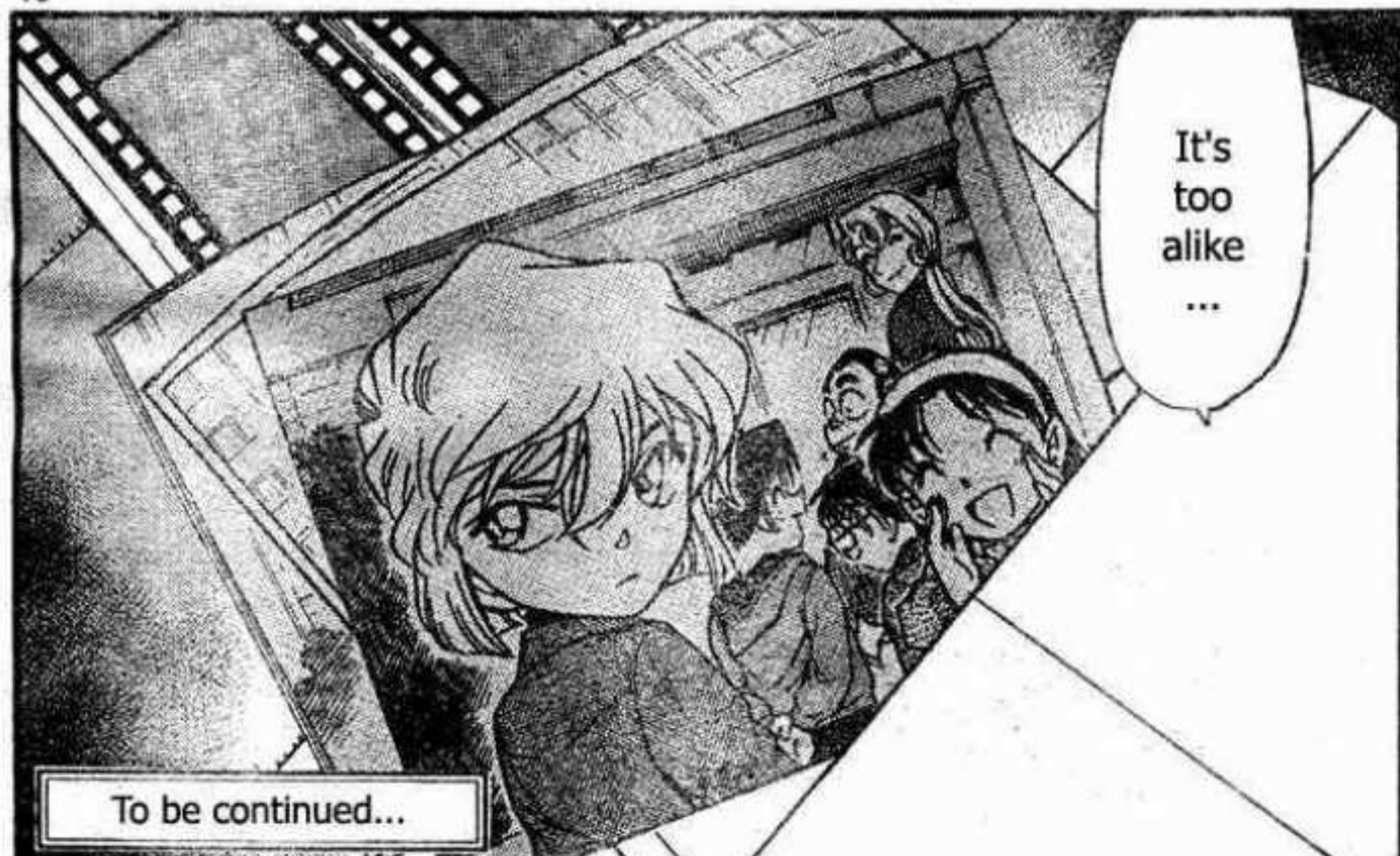
