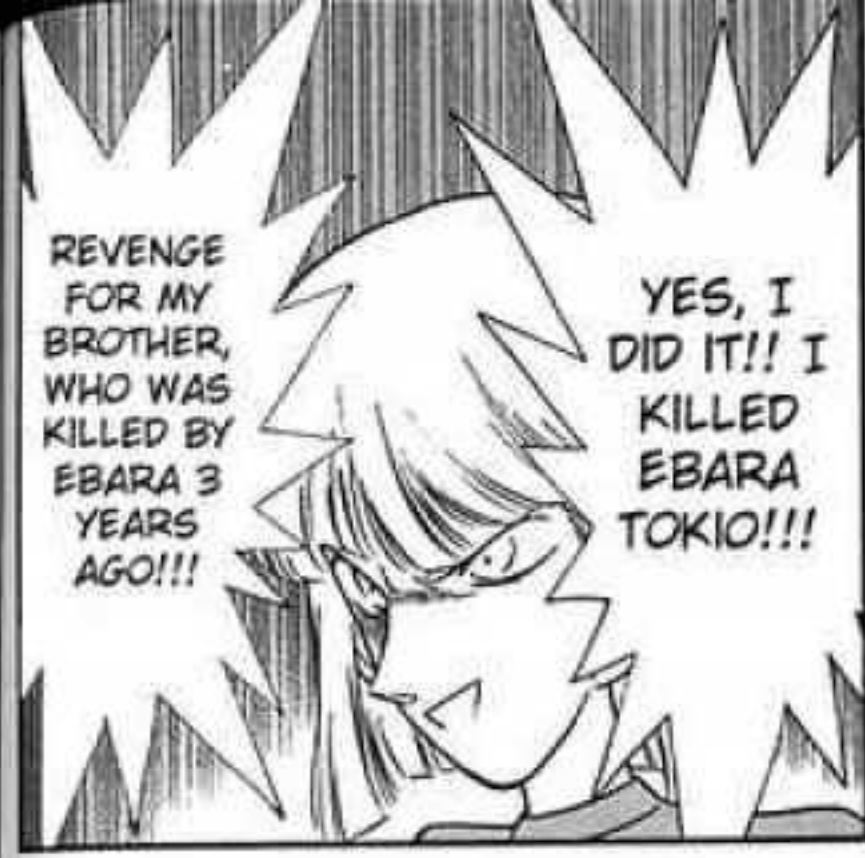
HE FELL AS MY BROTHER DID!!!

THE BAIT WAS THE INFAMOUS COMPUTER VIRUS, NIGHT BARON!!



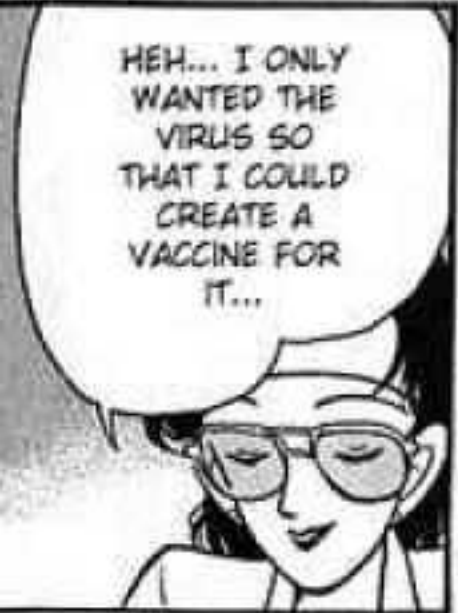
AND THOUGHT OF THIS "MYSTERY TOUR"!!

OH, SO THAT'S WHY YOU PUT HIM TO SLEEP IN THE PUB.

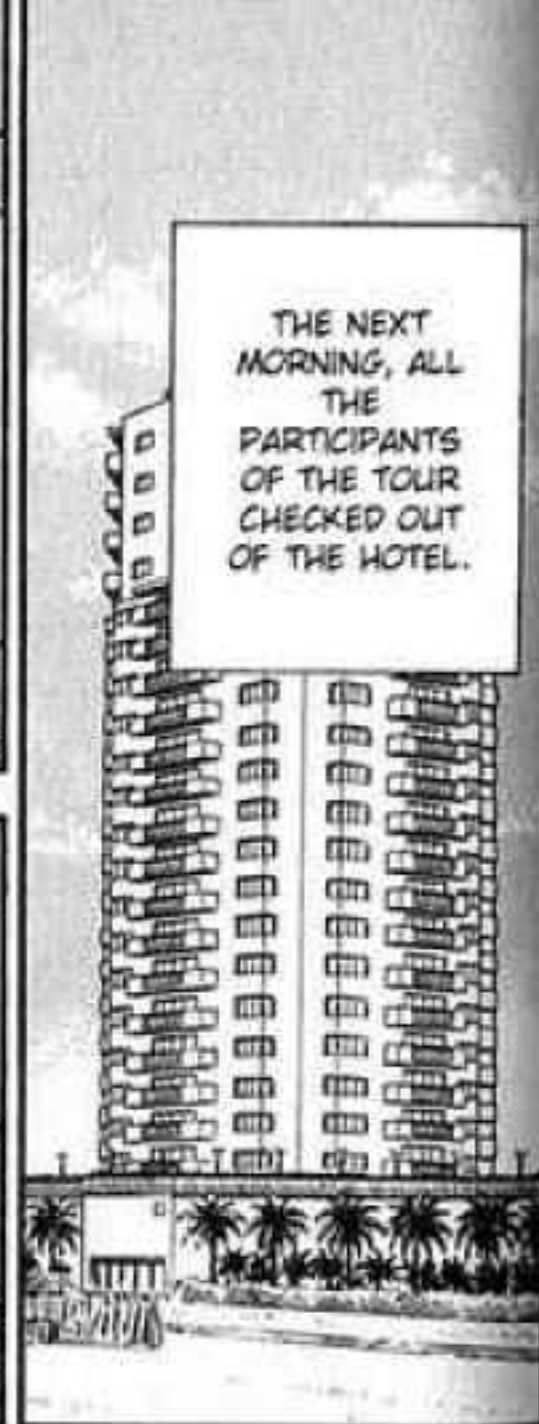


HEH... I ONLY WANTED THE VIRUS SO THAT I COULD CREATE A VACCINE FOR IT...

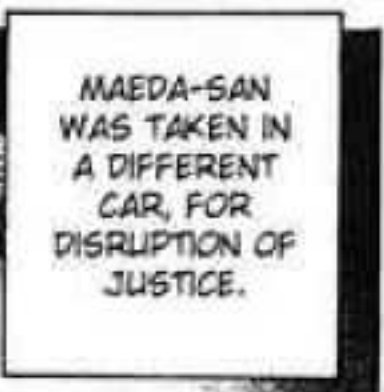


UNTIL YOU COME BACK...
